TRADE NOTICE

Sub: Implementation of Punitive Actions in Case of Incidents at Port Premises — Reg.

It has been observed that unsafe practices, negligence, and non-adherence to safety protocols have resulted in a number of incidents within port premises, ranging from minor unsafe occurrences to major accidents causing injury, fire, spillage, and environmental impact.

- 1. In order to strengthen a culture of safety, accountability, and responsibility among all stakeholders, the Punitive Action Framework is prepared, and the same will be applied in case of incidents occurring within port limits. The punitive actions include both Administrative Measures and Financial Penalties commensurate with the severity of the incident.
- 2. The punitive actions shall be imposed by the respective Departmental Heads of Deendayal Port Authority. In case of incidents involving departmental employees, punitive measures shall be decided and enforced by the concerned HoD, commensurate with the severity of the incident.
- 3. All port users, trade associations and other stakeholders are hereby directed to strictly comply with the statutory safety provisions and safety norms issued by the Port from time to time. Non-compliance leading to incidents will attract punitive action as per the punitive action framework, without prejudice to any other legal action under applicable laws.

This notice comes into effect immediately.
